This limit switch is manufactured from die-cast aluminum and powder epoxy-coated with stainless steel fasteners and shaft. With a weather-proof NEMA 4/4X and IP68 rating, the XLS-B4 is corrosion resistant and suitable for most environments.


XLS-C7-Series Limit Switch - Dimensions








XLS-C-Series Limit Switch Bracket - Dimensions


